Woods Valley offers an Instructor Training Course for those interested in becoming a ski or snowboard instructor or for experienced instructors interested in joining our team. Open to adult and junior skiers and riders. Juniors must be 14 years old by December 1, 2017.

- Our Instructor Training Course (ITC) starts with Orientation Day from 8:00 a.m. to 12 p.m. on **Sunday, November 26, 2017** and continues each weekend thru mid-December. Orientation consists of talks, demonstrations and videos of the American Teaching System. Certified course conductors will be on hand to discuss procedures, class handling, training preparations and general information. This is not a national ski or snowboard association certification course but it is a necessary first step if that's your goal.
- You will face rewarding challenges and make new friends as you improve your skills and progress from skier/rider to Instructor. We teach the American Teaching System of the Professional Ski and Snowboard Associations of America.
- Training continues every Saturday and Sunday from 9 a.m. to 12:00 p.m. We will evaluate you in mid-December.

Terms, release of liability and Conditions

1. I acknowledge that skiing/snowboarding is **hazardous** and that there are many **inherent risks** in these sports, including but not limited to variations in terrain, surface and subsurface snow, ice conditions, moguls, bare spots, forest growth, rocks and debris, lift towers and other obstacles and hazards. I acknowledge that snowmaking and snow grooming may be in progress at any time.
2. I have read and will obey the guidelines issued under the RESPONSIBILITY CODE as found on the Woods Valley website. I agree to ski/ride in control and with care at all times.
3. I agree, for myself and/or my child, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby **release, indemnify, and hold harmless** Woods Valley, its officers, officials, agents, representatives, affiliated companies and/or employees (collectively as "RELEASEES") from liability for any and all loss or damage to myself or to my child or my or my child's property resulting from the RELEASEES' **negligence** or any other cause. I understand that the RELEASEES are not responsible for the consequences of their own **negligence**, that is, their failure to use reasonable care in any way. I acknowledge that I am freely and expressly assuming and accepting any and all risks of property damage, personal injury and death in connection with my or my child's use of the resort or participation in skiing/snowboarding including any instructional lessons.
4. Pass must be worn on the outside of the skier's clothing and be clearly visible at all times to ski area personnel.
5. For parents/guardians of participants of minority age (under Age 18 at time of registration) this is to certify that I individually or as parent/guardian signing this agreement for the named Minor, acknowledge and agree that I have read the above release of liability and that by signing this release on behalf of the minor, I and the minor agree to be bound by its terms. I hereby agree to **release from liability, FOREVER DISCHARGE, indemnify and hold harmless** Woods Valley its officers, officials, agents, representatives, affiliated companies and/or (collectively as "RELEASEES") for any and all loss or damage to my child or my or my child's property resulting from the RELEASEES' NEGLIGENCE or any other cause arising out of said minor's use of the resort or participation in skiing/snowboarding including any instructional lessons.
